



Liability Waiver

In consideration of the services of Paper Doll Militia Limited (UK) and Paper Doll Militia LLC (U.S.), their agents, owner, officers, volunteers, participants, and all other persons or entities acting in any capacity on their behalf (hereinafter collectively referred to as Paper Doll Militia, I hereby agree to release, indemnify, and discharge Paper Doll Militia, on behalf of myself, my spouse, my children, my parents, my heirs, assigns, personal representative and estate as follows:

1. I acknowledge that my participation in circus arts training and instruction, including aerial arts, gymnastics and other disciplines entails known and unanticipated risks that could result in physical or emotional injury, paralysis, death, or damage to myself, to property, or to third parties. I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. The risks include, among other things: exposing its participants to the potential for: slips and falls and falling; rope burns; pinches, scrapes, twists and jolts that could result in scratches, bruises, strains, sprains, cuts, lacerations, fractures, concussions, or even severe life threatening hazards; muscle soreness and fractures; musculoskeletal injuries including head, neck, and back; injuries to internal organs; the negligence of other people; my own physical condition; and the risk of emotional and psychological injuries or physical damage associated with this activity. Traveling to and from shows, meets and exhibitions raises the possibility of any manner of transportation accidents. In any event, if you or your child is injured, you or your child may require medical assistance, at your own expense. Furthermore, Paper Doll Militia representatives have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They might misjudge the weather or other environmental conditions. They may give incomplete warnings or instructions, and the equipment being used might malfunction.

2. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.

3. I hereby voluntarily release, forever discharge, and agree to indemnify and hold harmless Paper Doll Militia, from any and all claims, demands, or causes of action, which are in any way connected with my participation in this activity or my use of Paper

Doll Militia's equipment or facilities, including any such claims which allege negligent acts or omissions of Paper Doll Militia.

4. Should Paper Doll Militia, or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold them harmless for all such fees and costs. 5. I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating, or else I agree to bear the costs of such injury or damage myself. I further certify that I am willing to assume the risk of any medical or physical condition I may have.

6. Remote Training Liability statement

6.a. Location: I acknowledge that the instructor is not present with me and it is my responsibility to ensure the area is clear, safe and free from any hazards which may cause injury to me or to others.

6.b. Self Assessment: I acknowledge that I am responsible for exercising within my own skill and fitness levels. If at any time I feel the moves I am completing are above my current skill level I will cease immediately. Likewise if I feel any discomfort, pain, sickness or dizziness I will immediately stop the activity.

6.c. Equipment, Rigging & Attire: I acknowledge that I will be only using the safety mats, equipment, and rigging points that were approved by Paper Doll Militia for this course. The company does not accept any responsibility for faulty/defective equipment or incorrect usage. The participant is to have all jewelry / watches removed, and be in appropriate activewear.

6.d. Video: All participants are to conduct ALL movements within view of the camera lens. Coach will record each lesson from start to finish (and notify participants before the lesson of this). Pre-recorded video meeting the above criteria can only be shared privately with existing customers. All recordings will be kept for 30 days assuming the class ran smoothly with no incidents, falls or injuries. If any incident did occur then recordings should be kept for a minimum of 24 months from the date of recording (best practice would be to retain all recordings for 24 months and we would recommend coaches do this if at all possible)

7. By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Paper Doll Militia, on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.
